- c. Provide more information about the existing and proposed HVAC units as the indoor units may become visible with the new clear glazing. ARC suggested using frosted or etched section(s) of the glass to hide any visible mechanical equipment.
- d. Submit more photos of the full length of the building.
- e. Any proposed signage requires a Sign/Awning application to be submitted to ARC.
- f. Applicant explained that their business aesthetic goes well with this building because of the midcentury modern style.

The applicant shall submit updated drawings to reflect the following:

- a. **Remove the tag line “Message Facial Waxing” and address number “103” from the awning. Decals can be placed on door for these elements. ARC also recommends removing the existing “103” decals on facade to be replaced with a more sophisticated “103” on door.**
- b. **ARC finds that the curved lettering of “Zen Spa” is not working aesthetically. ARC recommends lettering to be on two lines and not curved.**
- c. **The purple coloring of the awning matches the neighboring business, and this may be confusing but ARC accepts the proposed purple sunbrella fabric as proposed.**
- d. **Provide a mechanical of the proposed sign to show size, spacing, name of font, etc.**
