Call To Order: The meeting was called to order at 8:40 a.m.

Minutes: Minutes of the January 16, 2019 meeting were distributed. There was no discussion about the content. Motion to approve was tabled until Mr. Burweger arrived. At that point, a Motion was made to approve the Minutes. Seconded and carried with one abstention by K. Burgweger.

Report: L. Helmrich reported on a discussion with the Junior League concerning a potential program on Technology to be offered in the 2<sup>nd</sup> half of April or the beginning of May. Information on the contents of the program will be available at a later date. The work on the Tech Lounge is continuing and the removal of asbestos will be complete by mid-March. The space has been basically gutted and the new layout will have seminar tables and seating for 16, which can be reconfigured as needs dictate.

In answer to a question posed by S. Katz, we discussed the value of the Tech space which initially will be used as a drop-in center for seniors who want/need access. There is a recognition that the usage of the Lounge will be evolutionary as needs arise and that it will vary depending on the age and abilities of the seniors involved. There was a question as to whether we could partner with Apple or another tech company to expand the capabilities of the Lounge. It appears that this is one of many areas to investigate in utilizing the new Tech space to its maximum potential.

Report: L. Contadino reported that much effort has been expended in the past month on the Senior Tax Credit program which is required to be updated this year. She again acknowledged K. Burgweger's efforts to shepherd the revised plan through the town approval process. COA committee members will help in this process.

She also reported on some upcoming events that involve the COA. On February 21 the Greenwich Bar Association has invited her to give an overview of the commission and its activities to their monthly luncheon.

On May 3<sup>rd</sup>, Bonnie Levinson will present a workshop on "Greenwich Lives Well Lived" which includes a broad perspective of town residents discussing their experiences. On May 31, we are again coordinating the Late Life Conference whose theme is "Paving the Path from Loneliness to Engagement". Ruth Finkelstein is the keynote speaker and the cost is \$100, all-inclusive. S. Katz will be one of the presenters addressing technology issues.

The goal has been to have six events for our sponsors to reach the town seniors. Three of these have required a financial commitment from the sponsors and the other three have been bonus opportunities for them.

On April 3<sup>rd</sup>, the YWCA is offering an Elder Abuse Forum for health professionals. We will inquire of Meredith Gold whether this can be taped for potential future use.
