- In the "Policies and Practices" section at page 3, delete "Following acceptance the report shall be submitted to the BET."

- In the "Organization & Powers" section at page 18, in the sixth paragraph, insert a new sentence positioned between the second and third sentences currently appearing in last term's Handbook, that reads, "Items shall be added to the meeting agenda at the request of four members of the BET, communicated to the Chairman at least ten business days prior to the meeting."
- In the "Policies & Practices" section at page 5, at the second paragraph from the bottom of the page, the last two sentences are deleted.
- In the "Policies & Practices" section at page 8, under "Transfers", at the end of the paragraph entitled "Policy", a sentence is added reading, "The Board of Education

shall submit for the information of the Budget Committee (but not for review by the full BET) proposed transfers in its Operating Budget across major object codes which shall be in excess of \$25,000." Ms. Oberlander suggested the following as a separate paragraph:

"As a practice adopted in July 2007, the BET has decided that BOE Transfers of up to \$_____ shall be at the discretion of the Comptroller. Transfers greater than \$_____ shall be reviewed and acted upon by the BET Budget Committee, with no action required by the full BET."
