

1. FY2020 Budget Guidelines

Ms. Moriarty provide an overview of the previous discussions of the FY2020 Budget Guidelines and thanked Committee members for their feedback on recent discussions and drafts. She had updated the Budget Guidelines from the version discussed at the October 18, 2018 meeting. The Committee discussed the various assumptions and objectives included in the Guidelines, including labor assumptions, legal settlements, inflation rates, possible impacts from the State, open capital appropriations of \$124 million, and the BOE Master Plan as context for their decision-making.

Upon a motion by Ms. Moriarty, seconded by Mr. Ramer, to approve Budget Guidelines as presented.

Ms. Tarkington made a motion to amend, which was seconded by Mr. Mason, to change the Budget Guideline's target range of mill rate increase to 2% - 3.25%. The Committee voted 2-2 on the motion to amend. Motion failed. (Opposed: Moriarty, Ramer)

On the original Motion to approve Budget Guidelines, the Committee voted 3-0-1. Motion carried. (Abstained: Tarkington)

Upon a motion by Mr. Ramer, seconded by Ms. Tarkington, the Committee voted 4-0-0 to adjourn the meeting at 9:55 A.M. Motion carried.
