Decision Status: Discussion only amongst members Hein and Pugliese (Brake-Smith recused), item will be placed on 11/2 meeting for motion /vote

ARC makes the following recommendations:

- a. Signs must be confirmed to be on the property, ie “back of lot line”.
- b. ARC asks for confirmation that the proposal meets the residential signage guidelines, Section 6-163, with specific attention to monument signage and lighting.
- c. At corner of Steamboat, applicant to review the alignment of the freestanding sign so the placement has more visual engagement with existing site elements.
- d. ARC finds it important to avoid visual chaos. Donor signs should be limited to a maximum, and designated locations should be notated on plans.
- e. Locations of future sculpture locations were discussed. ARC strongly recommended against lighting sculptures and applicant indicated they would not be illuminated. Staff will research prior projects to determine if ARC has right of review for sculpture installations.
