A potential resolution to allow the BET to transfer funds from the General Fund to the Risk Fund, if needed, was also discussed. This request arises from the Finance Department since the Comptroller has advised the BET that the Risk Fund may be depleted before the end of FY2019, that is June 30, 2019, due to judgments and settlements in several legal actions brought against the Town. Currently both BET and RTM approval are needed to make such a transfer. This would require BET approval alone to establish a more efficient process. The alternative would be to increase the amount in the Risk Fund, but once funds are moved to the Risk Fund, they cannot be allocated for another purpose.
