RESOLUTIONS REGARDING 2017 – 2018 DEPARTMENT OF HEALTH BUDGET

WHEREAS, the Director and those assisting her spent considerable time preparing the proposed 2017-2018 budget for the Department of Health (the "Department");

WHEREAS, the Budget Overview Subcommittee of the Board met twice to review, discuss and revise the proposed budget;

WHEREAS, the Department of Health is a town agency serving Greenwich residents;

WHEREAS, the Department provides services that protect the public health;

WHEREAS, the Department offers flu clinics in the community throughout the month of October providing the latest influenza, pneumococcal and adult vaccines;

WHEREAS, the Department has an Immunization and Blood Pressure Clinic that offers blood pressure screening and immunizations for adults and children in the community;

WHEREAS, the Department's Special Clinical Services Division provides counseling and treatment for HIV and STDs at scheduled clinics;

WHEREAS, the Department's Dental Health program routinely provides over 6,000 dental screenings and close to 3,000 fluoride rinse applications to public school students on a yearly basis;

WHEREAS, the Department's Laboratory has the state of the art equipment to provide tick testing, radon in air and water testing, blood lead testing for children under the age of 6 and analyzes water samples from private well water and community beaches; and

WHEREAS, the Department's Division of Environmental Services licenses, inspects and reviews plans on various facilities such as food services operations, day cares, private well water, beauty care operations, on-site sewage disposal systems, public swimming pools and responds to complaints about possible lead exposure, animal control issues and housing matters;

NOW, THEREFORE, on November 22, 2016, the following resolutions were adopted by the Board of Health:

RESOLVED, that the proposed 2017-2018 budget (the "Budget") for the Department is approved; and

FURTHER RESOLVED, that any reductions to the Budget would negatively impact the Department's ability to provide needed public health services to keep residents healthy and safe.
