## First Selectman's Committee to Re-Imagine Greenwich Meeting October 6, 2021

### 1. Welcome

The meeting was called to order at 12:00 PM. Attendance:

### 2. Approval of Minutes

Due to a computer (lack of internet) the minutes from September 1, were not available to approve.

### 3. Old Business

- a. 12-hour Parking Lot Maps: DPW is still incorporating feedback from Parking Services.
- b. Business Cleanup Day: Ms. Hull indicated it would be challenging to garner volunteers, we should continue to let DPW, and Park & Rec know when we see issues in our business districts.

### 4. New Business

- a. DPW Update:
  - a. The committee discussed areas where cellular service is lacking and the roll-out of 5G small cell antennas. This is not unique to Greenwich, with more connected devices and reduction in use of landlines. The town works with PURA and the CT Siting Council to prioritize locations for cellular carriers.
  - b. DPW also obtained a quote for decorative barriers. We need to think about how to fundraise via Greenwich Forward as a public/private partnership.
  - c. Outdoor Dining: We are currently working under executive orders which end March 2022, so the town needs to think about long term solutions, especially as it relates to parking.
- b. Free Music Fridays: Kudos to Mr. Rogers who put in 100 of hours to make this season happen. Ms. Cowie motioned to continue this initiative next year. Upon a second by Ms. Hull, the motion was approved unanimously.
