Sue Snyder: It will be a five K, this year, which is roughly 3.1 miles, and the reason we're doing that has to do with bridge construction at Bruce park has nothing to do with the pandemic.

Sue Snyder: But we're not having a kids half mile race on the track and that is a result of the pandemic, because the half mile race on the track there'd be too many kids crowding together at one time.
