Robert Stacy, Chief Human Resources Officer for Greenwich Public Schools, offered the following resolution, which was duly moved and seconded, regarding Item No. 1.

1. RESOLVED, that the Representative Town Meeting, in exercising its authority pursuant to Connecticut General Statutes, Section 7-474(b) hereby approves the funds necessary to implement the terms of the Greenwich Board of Education and the Connecticut Laborers' District Council on behalf of Public Service Employees Local, 136, of Laborers International Union of North America, AFL-CIO (Board LIUNA) collective bargaining agreement covering the periods FY 16/17, FY 17/18 and FY 18/19; said funds having previously been appropriated in the adopted budgets.

BE IT FURTHER RESOLVED that the Representative Town Meeting approves any terms of such agreement which may be in conflict with the Town Charter, special act, ordinance, rule or regulation adopted by the municipal employer or its agents of the Town.

Joshua Brown, Chairman of the Labor Contracts Committee, made a motion to postpone the item indefinitely.

The vote was now on Labor Contracts Committee's motion.
