-The Current % of Portfolio allocated to Diversified Fixed Income investments and Cash as defined in the latest IPS voted on October 29th, 2015 is 28.3% (Fixed Income: 24.4% and Private Debt: 3.9%) and 3.7% (Cash) adding up to **32%** of the Total Composite.
