## 2021 SUMMER SCHEDULE – Youth and Adult Tennis Clinic Instruction BRUCE PARK TENNIS COURTS

**DESCRIPTION:** Clinics are offered for those ages 4 and up. Instruction is provided at a variety of levels and focuses on all the fundamentals and rules of play in tennis. All classes will be held at the Bruce Park Tennis Courts. Fees are for one-week sessions (Monday – Thursday with a rain date of Friday).

**Must supply own racquet. Please bring one new can of tennis balls to the first day of the weekly session.**

**COVID-19 safety measures shall be in effect as necessary.**

**REGISTRATION DATES:**

- Online: Opens **Thursday, April 1** - online registration is only available to Greenwich residents. To register online go to [www.greenvichct.gov/webtrac](http://www.greenvichct.gov/webtrac), click on Parks and Recreation logo and log-in to your account.
- Mail-in for residents: Begins **Monday, April 19** - application should not be postmarked earlier than April 19.
- Mail-in for non-residents: Begins **Monday, May 3** - application should not be postmarked earlier than May 3. Registration will remain open until classes are filled.

Non-residents: primary family member and all participating family members, over 25 years, must provide identification and proof of address. Participants under 25 years, require a copy of birth certificate, passport, or guardianship.
