To determine eligibility for a Moderate-Income Dwelling (MID) Unit, the following documents must be submitted (where applicable):

1) Employment Income:

- \_\_\_\_\_ Employment verification form completed by the Employer.
- \_\_\_\_\_ Check stubs or earning statement showing Applicant's gross pay per period and frequency of pay (2 most recent paystubs).
- \_\_\_\_\_ W-2 and/or 1099 forms if the Applicant has had the same job for at least two years and pay increases can be accurately projected.
- \_\_\_\_\_ Notarized statements, affidavits or income tax returns signed by the Applicant describing self-employment and amounts of income, or income from tips and other gratuities.

2) Social Security, Pensions, Supplementary Security Income, Disability Income:

- \_\_\_\_\_ Award or benefit notification letters prepared and signed by the authorizing agency.

3) Unemployment Compensation:

10) Family Assets Currently Held: Documents provided must show the account holder's name.

\_\_\_\_\_ If an IRS Form 1099 is accepted from the financial institution for prior year earnings, the Administrator must adjust the information to project earnings expected for the next twelve (12) months.

13) Rental Income from Property Owned by Applicant:

**CHECKLIST: REQUIRED DOCUMENTATION FOR  
CERTIFICATION OF ELIGIBILITY FOR LEASE/RENTAL  
Moderate-Income Dwelling (MID) Units  
(GBZR 6-110)**

**APPLICANT(S) are required to provide to the ADMINISTRATOR the following documents:**

- Copies of Income Tax Returns (1040) for the past 2 years;
- Copies of W-2 and/or 1099 forms (showing income and employer) for the past 2 years;
- Copies of (2) most recent pay stubs from all employers.

NOTE: The Office of Planning & Zoning will not be able to provide a determination of income eligibility without the submission of the required documents as listed above.

**In addition to the above documents, the ADMINISTRATOR must submit to the Planning and Zoning Office the following:**

- Copy of the Lease that shows the monthly rent (rent must be within the permissible maximum rental fee under Greenwich Building Zone Regulation, Section 6-110);
- Copy of the advertisement notifying the public of the availability of the MID unit for rent/lease or any documentation showing notification to the public of the availability of the MID unit for rent/lease.
