ACCESS TO TENNIS COURTS ARE SUBJECT TO THE FOLLOWING RULES:

PLEASE READ THE FOLLOWING RULES CAREFULLY; THEY ARE INTENDED TO ENSURE YOUR HEALTH AND SAFETY, AND THAT OF FELLOW PLAYERS. ANYONE CAUGHT IN VIOLATION WILL BE ASKED TO LEAVE IMMEDIATELY AND MAY BE SUBJECT TO A LOSS OF TENNIS PRIVILEGES FOR THE SEASON.

1. TOWN OF GREENWICH TENNIS COURTS ARE OPEN AS WEATHER AND CONDITIONS PERMIT.
2. ALL USERS MUST CONFORM TO ALL OF THE MOST RECENT REQUIREMENTS IN EVERY ASPECT OF THE PHASE 2.1 REOPENING RULES FOR CONNECTICUT. THESE RULES ARE SUBJECT TO CHANGE BASED ON UPDATES TO THE STATE OF CT SECTOR RULES FOR REOPENING.
3. SOCIAL DISTANCING OF AT LEAST 6 FEET MUST BE MAINTAINED AT ALL TIMES WHEN ON THE PROPERTY INCLUDING IN THE PARKING LOT. YOU MUST LEAVE THE PROPERTY IMMEDIATELY AFTER YOUR VISIT AND NOT CONGREGATE.
4. EVERYONE MUST HAVE A CLOTH FACE COVERING OR HIGHER LEVEL OF PROTECTION WHENEVER CLOSE CONTACT IS UNAVOIDABLE WHILE USING THE PARK/SCHOOL FACILITIES.
5. SINGLES AND DOUBLES TENNIS IS PERMITTED. PICKLEBALL IS PERMITTED AT CHRISTIANO AND LOUGHLIN AVENUE COURTS.
6. TENNIS PASSES ARE NEEDED FOR PLAY ON ALL PUBLIC PARKS AND SCHOOL COURTS. (CHILDREN 5-15 YEARS OLD USE ACTIVE PARK PASSES; SENIORS USE SENIOR PARK PASSES.)
7. **TENNIS RESERVATIONS MAY BE MADE STARTING MAY 3, 2021.** RESERVATIONS ARE AVAILABLE ONLINE AT www.greenwichct.gov/webtrac; BY PHONE AT 203-622-2210; EMAIL AT tennis@greenwichct.org. RESERVATIONS MAY BE MADE FOR ANY TOWN TENNIS COURT 7:00 AM TO 7:00 PM. THE EASTERN GREENWICH CIVIC CENTER COURTS ARE AVAILABLE 7:00 AM TO 9:00 PM. RESERVATIONS MAY BE MADE 24 HOURS IN ADVANCE ONLINE; PLEASE BRING YOUR RESERVATION RECEIPT TO THE COURT.
8. IN ADDITION TO THE ABOVE, ALL OTHER REGULAR TENNIS COURT RULES APPLY.

Although we will continue to make every effort to provide a healthy environment, **PLEASE MAKE RESPONSIBLE DECISIONS, BASED ON YOUR PERSONAL RISK PROFILE, ON WHETHER TO EXPOSE YOURSELF TO OTHERS.**

We will continue to provide access to our customers during this heightened alert period as long as everyone obeys the above safety practices.
