THE FIRST SELECTMAN, IN COLLABORATION WITH HIS EMERGENCY MANAGEMENT TASK FORCE ANNOUNCES THE MANAGED RE-OPENING OF THE TOWN SKATEPARK.

ACCESS TO THE SKATEPARK IS SUBJECT TO THE FOLLOWING RULES:

PLEASE READ THE FOLLOWING RULES CAREFULLY. THEY ARE INTENDED TO ENSURE YOUR HEALTH AND SAFETY, AND THAT OF FELLOW SKATERS. ANYONE CAUGHT IN VIOLATION WILL BE ASKED TO LEAVE IMMEDIATELY AND MAY BE SUBJECT TO A LOSS OF SKATEPARK PRIVILEGES FOR THE SEASON.

1. SOCIAL DISTANCING OF AT LEAST 6 FEET MUST BE MAINTAINED AT ALL TIMES WHEN ON THE PROPERTY INCLUDING IN THE PARKING LOT. YOU MUST IMMEDIATELY LEAVE THE PROPERTY AFTER YOUR VISIT AND NOT CONGREGATE IN THE PARKING LOT.
2. EVERYONE MUST HAVE A CLOTH FACE COVERING OR HIGHER LEVEL OF PROTECTION WHENEVER PARTICIPANTS ARE WITHIN THE FENCED AREA OF THE SKATEPARK AND WHENEVER CLOSE CONTACT IS UNAVOIDABLE WHILE USING THE PARK FACILITIES OUTSIDE OF THE FENCED AREA.
3. BEGINNER SKATERS ARE REQUIRED TO BRING AND WEAR A HELMET, KNEE AND ELBOW PADS AND WRIST GUARDS. MORE EXPERIENCED SKATERS ARE REQUIRED TO BRING AND WEAR A HELMET, KNEE AND ELBOW PADS. NO BORROWING OR SHARING OF EQUIPMENT IS PERMITTED.
4. ADMISSION FEES ARE \$10 PER DAY OR \$30 PER MONTH. DAY AND MONTHLY PASSES MAY BE PURCHASED AT THE PARK OR ONLINE AT WWW.GREENWICHCT.GOV/WEBTRAC BEFORE ENTRANCE INTO THE PARK.
5. THERE WILL BE A LIMIT OF 8 SKATERS IN THE SKATEPARK AT A TIME. IF SKATERS ARE WAITING TO COME IN, THE PARTICIPANTS IN THE SKATEPARK WILL HAVE A 2 HOUR TIME LIMIT BASED ON SIGN IN TIME.
6. IN ADDITION TO THE ABOVE RULES, ALL OTHER REGULAR SKATEPARK RULES APPLY.

Although we will continue to make every effort to provide a healthy environment, **PLEASE MAKE RESPONSIBLE DECISIONS, BASED ON YOUR PERSONAL RISK PROFILE, ON WHETHER TO EXPOSE YOURSELF TO OTHERS.**

We will continue to provide access to our customers during this heightened alert period as long as **EVERYONE OBEYS THE ABOVE SAFETY PRACTICES.** We will continue to monitor the recommendations by the CDC, local, state and national authorities and keep you updated on changes. **IF YOU, A FAMILY MEMBER OR SOMEONE YOU HAVE BEEN IN CONTACT WITH HAS RESPIRATORY SYMPTOMS, PARTICULARLY A FEVER, DO NOT VISIT TOWN FACILITIES.**
