## TO ALL MEMBERS OF THE RETIREMENT SYSTEM OF THE TOWN OF GREENWICH


An employee member position on the Retirement Board has become vacant. Under Sections 2.73-85 of the Greenwich Municipal Code, which governs the election of employee members to the Retirement Board, a special election to fill the vacant position for the remainder of the term through February 3, 2023 will be held at Town Hall on Friday, July 24, 2020, between the hours of 7:00 a.m. and 9:00 a.m. and 3:00 p.m. to 6:00 p.m.

The election at Town Hall will follow guidelines set by the Health Department, which will be forwarded under separate cover in July.

Any employee who is a member of the Retirement System of the Town of Greenwich is eligible to be elected to the Retirement Board. To be placed on the ballot an eligible employee must be nominated by at least 25 members. Attached are the official petition forms to be completed by members of the Retirement System of the Town of Greenwich designating their nomination to fill the position. The completed petition forms must be filed no later than 4:00 p.m., on July 15, 2020, at the Office of the Town Clerk, Town Hall, Greenwich, Connecticut. The elected nominee will serve as a member of the Retirement Board from July 25, 2020 through February 3, 2023.

### ELECTION REGULATIONS

1. ONE person only shall be nominated on a single petition.
2. Nominations shall be made by no fewer than 25 members of the Retirement System. Any petition signed by less than 25 members shall be void.
3. A statement of consent by the nominee to accept the nomination must accompany any petition. The nominee must be a member of the Retirement System.
4. No member of the System shall nominate more than two persons and the signature of any person nominating more than two persons shall not be counted.
