- 1. Reference is made to the Feasibility Cost Sharing Agreement Approval Package (enclosed), which comprises:

- 2. In accordance with the referenced above, the Feasibility Cost Sharing Agreement Package for the Byram River Basin, Connecticut and New York Flood Risk Management Feasibility Study, is provided for NAD review and approval.
- 3. No deviations to the FCSA are requested. The model FCSA used is the version dated 05 June 2007. Previously, the Town of Greenwich requested a deviation to the Financial Self Certification statement. That deviation was approved by HQUSACE in a memorandum dated September 26, 2011 (Item 1.d.).
- 4. A letter from the Town of Greenwich, Connecticut indicates that the deviation to the Self Certification of Financial Capability for Agreements is requested to avoid conflicts with the Town of Greenwich Charter.

- 5. The District has addressed HQUSACE comment 6.a. of the memorandum approving the modified self certification form. The costs have been reviewed and updated per comment 6.a. The study, as described in the Project Management Plan, is in compliance with the 3x3x3 rule, as it is scheduled for 3 years with a budget of \$2,993,760. The study will be cost-shared 50/50. Because the Non-Federal sponsor will be contributing its entire share as in-kind services, the costs of cash contributions under Articles III and IV total \$0, and the cost of in-kind contributions is \$1,496,880.
- 6. The District is prepared to execute this FCSA immediately upon approval by NAD.
